### SBA 8(a) Sole Source Guide

The Small Business Administration (SBA) allows government agencies to award contracts directly to participants in the 8(a) business development program without competition. Analytica is an 8(a) participant through March 28, 2025.

#### Benefits of 8(a) Sole Source

- Simplified procurement process A contract can be awarded with a less detailed procurement document and time to award is usually within weeks
- Lower administrative costs Shorter procurement time and easier decision making process
- Best Value Pricing Agency can get the best value as they negotiate directly with the firm
- Best Value Services Agency can determine and evaluate the capabilities of desired 8(a) firm

#### Steps to establish 8(a) Sole Source

- 1. The interested government agency develops a statement of work, prepares a government price estimate, and obtains the necessary funding.
- 2. The interested agency chooses Analytica to perform the work and submits a procurement request to the agency's Contracting Officer (CO).
- 3. The agency's CO submits an "Offering Letter" to Analytica's SBA representative:
  - **Sheila B. Watson**, Business Development Specialist U.S. Small Business Administration. (202) 235-2969; Sheila. Watson@sba.gov
- 4. SBA then reviews and confirms Analytica's eligibility. If the contract is accepted, the agency can then proceed with developing a contract.
- 5. Analytica then submits a proposal which is evaluated and negotiated (if necessary) by the agency.
- 6. Once agreed upon, the CO prepares a contract award document and period of performance can begin as agreed.
